

A Hero Twice Over

The first time Bob Wirtz was called to be a hero was in 1944 when he enlisted in the US Navy. Bob served on the USS Randolph and at Boca Chica Naval Air Station

in Florida. When he returned home in 1946 he apprenticed at The Sheboygan Chair Company under the US GI Bill of Rights. Then in 1948 he married his sweetheart, Anna Mae. Bob met his mentor, (and 'second father') Bernard Mondloch at Sheboygan Chair Co. and eventually went to work for him at Mondloch Upholstery. When Bernard retired, Bob bought the business and began his long career serving many of Sheboygan's families at Wirtz Upholstery.

The second time Bob was called to be a hero was 23 years ago when he became his wife's caretaker. Over the course of the years Annie has had 3 paralyzing strokes – the last one left her visually handicapped as well. At 85 years old, Bob credits his success as a caretaker to training he received at the "Powerful Tools For Caregivers" workshop given by the Aging and Disabilities Resource Center where he learned the golden lesson, "put yourself in their place". Bob has installed banisters and grab bars throughout the house and has become *chief, cook,* and *bottle washer*. He also credits his success to Meals On Wheels. "Meals On Wheels is a bonanza! I don't have to worry about what we are going to eat next."

"I don't know what took me so long to sign up for Meals On Wheels."



Last year Bob received a special honor. He was one of three veterans from the area who were taken on the Honor Flight to Washington D.C. The vets were escorted to four of our nations memorials and given V.I.P. treatment for the day. "It was the second happiest day of my life," Bob said, "My wedding day was the happiest." Heroes....perhaps they are accidental. Most people who become a caretaker didn't set out to become one. And yet, most of them wouldn't have it any other way.
